NOTIFICATION

In pursuance of the approval of Government of Balochistan Education Department's Notification No.SO(Admn:)7-32/2009/Edn:/2631-34 dated Quetta the 12th March, 2011, vide approved para-4 of the Summary U.O. No 7-32/09-SO (Admn:)Edn:/745 dated 27th January, 2011 is pleased to amend in the existing admission policy for B.E session 2010-11 onwards against reserved seats of Balochistan in other provinces.

The Government of Balochistan is pleased to approve the following admission policy for reserved Engineering seats of Balochistan in the Engineering Colleges/Universities of other Provinces of the Country.

ADMISSION POLICY FOR BACHELORS IN ENGINEERING (B.E) AGAINST RESERVED SEATS FOR BALOCHISTAN.

2.01 The Distribution of (96) Seats will be made as per following Order:

(a) 07 Total Seats with FSc/ICS On Open Merit,

(06) Seats

(If any candidate after selection surrenders seat from open merit, the seat will be filled by next waiting candidate on provincial merit basis).

(b) One seat in University of Engineering Technology will be reserved for Diploma in Associate Engineering (DAE) on Provincial merit basis

(01 Seat)

(Only in University of Engg: & Tech Lahore Pakistan).

(If any candidate after selection surrenders seat from Provincial merit basis, then next approved waiting list from all six zones, the higher merit candidate will get the seat).

(c) 5% quota is reserved for Students with FSc/ICS belonging to Non Muslim Minority Community in any University of Engineering & Technology of Pakistan on Provincial Merit Basis. If minority candidates were not available then such surplus seats should be given to the Provincial merit.

(05 Seats).

(If any candidate after selection surrenders seat on Provincial merit basis, then next approved waiting list from all six zones the higher merit candidate will get the seat).

(d) One seat reserved for Female Candidates with FSc/ICS on Provincial Merit Basis

(01 Seat)

If female candidate is not available then male candidate can be considered for admission but he is not entitle PEC Scholarship.

(e) 2% quota is reserved for Physical handy caped students with FSc/ICS,

(2 Seats)

If physical handy caped candidates were not available then such surplus seats should be given to the candidates of Provincial merit.

Definition of disability in terms of (WHO) in case of impairment/disability/handicap:

IMPAIRMENT: Impairment is defined as “any loss” or abnormality of psychological, Physiological or anatomical structure or action: e.g. loss of foot, defective vision or mental retardation. Impairment may be visible, temporary or permanent aggressive or regressive. Further, one impairment may lead to the development of “secondary” impairments as in the case of leprosy are damage to nerves (primary impairment) may lead to planter (secondary impairment).

DISABILITY: Because of impairment, the affected person unable to carry out certain activities considered normal for his seat etc. “This inability to carry out certain activities is termed liability”. A disability has been defined as “ any restriction or lack

of ability to perform an activity in the manner or within the range considered normal for a human being.

HANDICAP: As a result of disability, the person experiences certain disadvantages in life and is not able to discharge the obligations required to him and play the role expected from him in society. This is termed “handicap” and is defined as “a disadvantage for a given individual, resulting from an impairment or a disability, that prevents the limits to fulfill the role that is normal (depending on age, sex, and social and cultural factors) for that individual”.

Taking accident as an example, the above terms can be explained further as follow:

Accident =====Disease for disorder.

Loss of foot ===== impairment (extrinsic or intrinsic)

Can not walk ===== Disability (objectified)

Unemployed ===== Handicap (socialized)

The candidate applying against the seat reserved for the disable person shall have to produce a certificate from the Medical Board, Bolan Medical College Hospital, Quetta as constituted by Government of Balochistan. The Medical Board shall be guided by the definition of the World Health Organization in respect of the disabled person. If there is no eligible candidate then the vacant seat shall be filled on purely open provincial merit. The selection committee reserves the right to refer it to special committee in case the medical certificate is not covered in accordance with the requirement of WHO.

Note: - Hard of hearing will not be considered as a disability.

f) One seat for employees of Colleges / Technology.
(01 Seat)

Total Seats:-16

The (80) Engineering District wise merit seats are distributed among Districts of Balochistan on population basis as per census report of Government of Pakistan. The population figures of (30) Districts are in accordance with the existing boundaries of the Districts.

Note: - THE APPLICANTS FOR CATEGORY a,c,d,e,f AND g WITH FSc (PRE-ENGINEERING/ICS ARE ELIGIBLE ONLY AGAINST THE REMAINING 97 SEATS.

2.03 In case of increase/decrease in the number of seats, the available number of seats to district shall be adjusted according to their population.

2.04 Except the Quetta District, non distinction is made between Urban and Rural areas of the province. In Quetta District those areas falling within limit of Quetta Municipal Corporation and Quetta Cantonment area treated as Urban area and remaining part of the district, as Rural area.

The Candidate from Quetta Rural must submit a certificate from the Local Government Department/Deputy Commissioner Quetta to the effect that as per present notification his/her place abode is a part of the Quetta Rural.

2.05 unclaimed District merit seats, if any shall be given to the candidates of the same Zone on Zonal merit basis and if there is no eligible candidate available in the respective Zone then such unclaimed seats shall be given to the candidates on Provincial merit basis.

2.06. No separate notice or letter shall be issued for inviting application, for any other instructions/directions to the candidates by advertisement or broadcasting through Radio or television shall be sufficient.

2.07. only the genuine Local/Domicile of Balochistan or those who have valid Local /Domicile certificate will be eligible for admission against the above seats reserved in various Engineering Colleges/Universities.

2.08 All seats in the above District are open for competition within each District to the Local/Domicile Candidates of the province of Balochistan and no one shall deny admission on the ground of race, religion, color or caste. Competition in each District shall take place between candidates of the District. Thus a candidate District “Q” shall not compete with a candidate of District “G”

2.09 The name of those candidates, who failed to appear for the interview before the Admission Committee on the scheduled date and time shall be deleted from the merit of the concerned district/category and they shall not be considered for the admission. Thus their absence from the interview shall amount to forfeiture of their right of admission. However, in the case of any intimation is received their names shall be kept pending till the last interview date for selection by Selection Committee.

2.10 The candidates who have passed the Higher Secondary School Certificate (HSC/HSSC) Pre-Engineering Examination or equivalent with Physics, Chemistry and Mathematics in Annual Examination of running year or earlier upto Annual Examination of Previous 3 years and have secured at least 60% marks in aggregate from any recognized Board of Intermediate and Secondary Education in Pakistan or from foreign countries, are eligible to apply for admission. In addition, the candidates who have passed Intermediate (Inter Computer Science Group) in Annual Examination of running year or earlier upto Annual Examination of Previous 3 years and have secured at least 60% marks in aggregate are also eligible for their admission only in Computer Systems Engineering, and on the availability of the other Technologies if accepted by the concerned University and they will not claim against other discipline which are reserved for F.Sc Pre-Engineering with Physics, Chemistry and Mathematics.

2.11 Candidate who did their F.Sc from other provinces following marks shall be deducted from the aggregate marks with following manner.

2) - Twenty marks shall be deducted from his/her F.Sc marks.

2.12 A candidate found in possession of two or more Local/Domicile certificate issued by the District Coordination Officer/Deputy Commissioner of different districts, at the time of interview shall not be considered for admission against the seats of District on Domicile/Local certificate. His/Her application shall be rejected by the Selection Committee.

2.13 A candidate who does not take admission in the Engineering College, after his/her selection by the Selection Committee in a particular year shall not be debarred from selection during the subsequent year. However he/she shall have to under go all the process and fulfill all the formalities during the subsequent year i.e Submission of application in time, appearing before the selection committee Shall be granted admission in the College and University of the country after his/her selection by the selection Committee.

2.14 The Selection Committee on the basis of the documents attached with the application forms on account of further inquiry from the Deputy Commissioner or other sources, shall be competent to decide whether a candidate actually belongs to the district of which he/she produced the Local/Domicile certificate, whether he/she is entitle for

selection against the seats of the district or not. The candidate shall be bound to abide by the decision of the Selection Committee.

2.15 Application for admission will be invited by the Director of Colleges & Higher Education Balochistan, Quetta through advertisement. Candidates will apply through online portal i.e. **www.chte.gob.pk or portal.chte.gob.pk.**

The prospectus and video “How to apply” is available at the above mentioned website. Fill the form carefully. After submission of form candidates could not change their priorities.

Challan slip (treasury receipt) bearing account number can be downloaded from the given website, where candidates have to **submit fee Rs.1000/- (One Thousand Rupees) in any branch of UBL**, before applying for online admission. The application forms will be accepted on or before the specified date. After expiry of the given date and incomplete application forms shall not be entertained.

2.16 The following attested documents in triplicate must have attached with application forms of shortlisted candidate (Only).

1. F.Sc Pre-Engineering with D.M.C.
2. Matriculation certificate, D.A.E passed Certificate with D.M.C.
3. Local/Domicile Certificate from the Deputy Commissioner Office.
4. Character certificate from the Principal of the college last attended.
5. Eight copies of latest passport size photographs.
6. An affidavit on the Non-Judicial Stamp paper, duly attested by the first class. Magistrate, stating that the candidate is in possession of only one Local/Domicile certificate.
7. National Identity card of the candidate or his/her father's in case he/she is below 18 years of age.
8. Birth certificate/B-form issued by NADRA.
9. Equalance certificate for A level student given by IBCC
10. Disability / Handicap Certificate issued by NADRA or Medical Board or Social welfare department.
11. Hafize ul Quran certificate from the Madresa registered in wafa ul Madress.
12. If the parents of candidates are employee of Colleges Higher and Technical Education must provide the employee certificate from the Department

2.17 (a) **Selection** of candidate for admission shall be made by the Selection Committee strictly on the basis of merit in each category of seats amongst the applicants according to prescribed conditions and an entry test will be conducted under arrangement by the Director of Colleges Higher and Technical Education Balochistan Quetta the marks used for establishing merit will be calculated by giving weightage as following:-

a) Total Weightage of F.Sc/ICS/DAE 50%.

b) Total Weightage of Entry Test, 50%.

- b) In case the calculated marks of two or more candidates are equal the candidate securing higher marks in Mathematics and physics shall be ranked higher in merit (production of equivalence or marks sheet shall be the responsibility of the candidates) **and if they have the same marks the age shall be ranked.**

2.18 The order of merit for selection shall be as under: -

- a) F.Sc (Pre-Engg: Group) 60% calculated marks (or above 60%).
b) F.Sc (Computer Science Group) 60% calculated marks (or above 60%).

Note:- The student having less then 60% marks in F.Sc/ICS/DAE are not eligible for admission against reserved (Engineering) seats of Balochistan in Universities/Colleges of sister provinces.

2.19

One percent from total marks obtained in FSc/ICS/DAE will be deducted from the candidates who have passed Additional Math, Bi-Annual/Annual in the running year and onwards and the same will be applicable for each gape. This deduction is applicable whether the HSSC/Diploma examination had been repeated or the gap had occurred owing to any other reason.

Explanation: -

- a) In case a candidate dose not clear F.Sc (Pre-Engineering) examination or part of a year, beyond this period shall be treated his/her attempt for the purpose of deduction irrespective of his/her having not appeared in the examination in such year.

- b) The Entry Test paper shall consist of 150 MCQs as per following detail: -**

Note: - Candidate, who have passed Intermediate examination with the subject of Computer Science may take entry test in Computer Science as a subject instead of chemistry.

Examples for obtaining the calculated marks:

- 1) Calculate Marks of F.Sc. Pass candidates securing 660
Adjusted marks out of 1100 and entry test score 75 out of 150.

Solution: -

(I) F.Sc Marks Calculation out of 50%.

Adjusted Marks secured in F.Sc	=660
Total Marks (F.Sc)	=1100
Marks Secured out 70	(I) $= (660/1100) \times 50 = 30.00$

(II) Entry Test Marks Calculation out of 50%.

Marks obtained in Entry Test	=75
Total Marks of Entry Test	=150
Marks out of 100	(II) $= (75/150) \times 100 = 25.00\%$

(I) DAE Marks Calculation out of 50.

Adjusted Marks secured in DAE	=2200

(II) Entry Test Marks Calculation out of 50.

2.20 The candidates who apply for their admission on the basis of fake certificates/documents (detected before or after their admission) shall be prosecuted under criminal law and their admission shall be cancelled. Additionally, they may also be debarred for a period of three years for applying against any reserved seat through Directorate of Colleges.

2.21 The Selection Committee for interview and selection of the candidate shall consist of the following: -

2.22 The meeting of Selection Committee for Interview of the candidates shall be held in the office of the Chairman Balochistan Public Service Commission at Provincial Head Quarter.

2.23 The quorum of the meetings of the Selection Committee shall be Three (3). The meeting of the Committee shall be presided over by the Chairman and in his absence by the Secretary Government of Balochistan Education Department.

2.24 The recommendation of the Selection Committee shall be submitted to the **Secretary Education** for final approval.

2.25

- a) The candidate must mention his/her choice in the application form which shall be considered final.
- b) A seat once allocated to a candidate by the selection committee duly approved by the competent authority shall not be treated as vacant/unclaimed, if the candidates leave the seat after 2 weeks after admission or if nomination of a candidate is withdrawn, after 2 weeks after date of admission of or the nominated candidate fails to join within 2 weeks of the commencement of academic session, subject to the approval and relaxation by the concerned University.

2.26 The Government of Balochistan reserves the rights of making any addition or amendment in the admission policy any time. A candidate once admitted against the reserved seat in any Province in any Professional College/University of the country shall not be considered for selection in any other Engineering College/University against the reserved seat of Balochistan.

2.27 Procedure of allocating seats.

- a) ROUND SYSTEM will be applied while allocating seats, each district including Quetta (Rural) will be recommended for selection as per his/her choice on merit, similarly the second round, third round and so on, so forth will be recommended for selection according to merit from the districts out of reserved quota for the districts.

In the last stage, seats will be allotted to the left over un opted technologies among those who would not compete against merit and who will be in the waiting list.

- b) Preference will be given to the technology only on the basis of the choices quoted by the applicant at the time of submission of application form rather than the institution where ever options are not available. However, the

Selection Committee reserves the right to allocate any Technology/Institute to the candidate as per his own merit.

- c) If the chosen technology/institute is not available, then the **Directorate** will allot the technology/institute against the available technologies.
- d) Once allotted technology/Institute is not challengeable however in case of mutual exchange only those candidates are allowed who are in same round.

2.28 Candidates who have passed three years diploma from a recognized Board of Technical Education Pakistan in approved discipline i.e Civil, Electrical, Mechanical, Electronics, Chemical, Glass & Ceramics and Petroleum Technology in Annual Examination current year or earlier upto Annual Examination of Previous 3 years and has secured at least 60% marks are also eligible to apply for admission under reserve quota 'B' in the same discipline only under the Regular passed three years Diploma before Annual Examination Previous 3 years within last 3 years will be eligible for admission.

2.29 The candidates, who have a certificate of Hafiz-e-Quran on printed form from any Government Registered Madressa, are also considered to have additional five (05) marks to be added to the marks of HSSC, provided that he/she qualifies the test conducted in the relevant field by the Directorate of Education (Colleges).

2.30 The Candidates who are already in service, should attach **NO OBJECTION CERTIFICATE** duly signed by the controlling authority/Head of Department. After selection to the First Year Class, they will be required to submit study leave order and reliving order from their employer for study purpose at the University because the Bachelor's degree program is a regular full time and day program. No student is allowed to engage himself/herself in any employment during his/her studies.

2.31 Candidates who were admitted previously in any batch/year in any discipline or category are not eligible to apply for admission again and their application shall be rejected without any notice.

2.32 Since the application form is a legal document, any wrong information provided therein, over-writing or tampering in any other way is illegal and may result in outright rejection of the form without notice.

2.33

- a) The candidate or his/her father/mother/Grand Father must have obtained Domicile Certificate/Local certificate at least 5 years prior to his application for admission against reserved Engineering Seats and in case of under age below the age the name of the candidate must be included in his/her Guardian/Mother/Father Local/ Domicile Certificate as son/daughter. In case of domicile he/she will also provide his/her Grand Father Domicile Certificate to Selection Committee. He/She will also provide B-form issued by NADRA.
- b) A candidate or his/her father/mother/guardian as the case may be found in possession of two or more local/domicile certificates issued by competent authority of different Districts/Agencies at the time of applying for admission shall not be considered for admission against the seats of any District/Agencies

for which he or she has applied. Such cases can only be considered if the parents/guardian or the candidate submit an affidavit that their earlier Local/Domicile Certificate have been canceled at least 2 years before the date of application for admission against the reserved Engineering seats. In case the candidate fails to mention or submit an affidavit he/she shall not be considered for admission. The Selection Committee will have the right/authority to debar such candidates for upto 3 years.

No Candidate will be selected in UET Lahore scoring less than 60% total adjusted marks/calculated marks/weightage as per UET Lahore admission policy vide No.Univ/AC/SS/162 dated 08-09-2012.

2.35

No Candidate will be selected in Dawood College of Engineering & Technology Karachi having more than 22 year of age as per DCET Karachi admission policy.
